

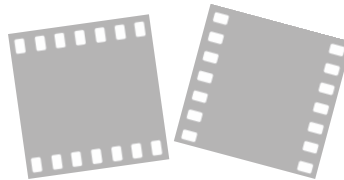
# Help Us Collect the Faces of Diabetes
